**Electricity Act 1989 - Overhead Lines (Exemption) (England and Wales) Regulations 2009**

UK Power Networks are submitting this notice under the terms of the Overhead Lines (Exemption) (England and Wales) Regulations 2009. These exemption regulations, which supersede the Electricity Act 1989 - Overhead Lines (Exemption) Regulations 1990, require the Council to determine within six weeks of receipt of this notice whether it is considered that the proposed works require consent under Section 37 of the Electricity Act 1989.

Location: The Brambles. Collins Road, Little Maplestead CO9 2SG

**Details of Proposal**

UK Power Networks are proposing to install a new pole and stays within an existing line in order to terminate the overhead line on the northern boundary of a site. Site subject to planning consent for a new bungalow.

It is deemed that these works are classed as exempt pursuant to section 3(1)(f) the installation or keeping installed, subject to the limitations in regulation 4 and the provisions of regulation 5, of one or more additional poles to support an existing line. I would be grateful if the planning department would fulfill their requirement to review this matter and complete the form overleaf and return within six weeks from the date of this notice ([MBX-AMSurveyors@ukpowernetworks.co.uk](mailto:MBX-AMSurveyors@ukpowernetworks.co.uk)).
