Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 (Elm) - Crown reduce to 8m approx. Crown thin 30% - Crown lift to 4m - phone lines pass through this tree to neighbouring property and branches overhang the lane and our garden.

T2 (Elm) - Crown reduce - Crown thin 30% branches overhanging guttering and close to property.

T3 (Elm) - Crown reduce and remove side branch.

T4 (Elm) - Question re health of the tree, may need removing otherwise crown reduce, lift and thin.

T5 (Elm) - Clump of smaller trees together need general trimming and tidying.

T6 (Sycamore) - Expired planning application 2020/21975 /TPO (not sure why TPO has the council put this on it as not aware of any TPO's!) this tree is a multi stemmed sycamore and needs heavily thinning and crown reduction and lift. Phone lines pass through this tree and are now badly snagged, this line has been replaced in the past due to this happening.

General comments.

Due to the fact the lane is unadopted, effectively a dirt road, there is a lot of water coming off the trees both on Brook View and the PC owned trees on BeckSide, causing damage to our section of the lane creating potholes which need regular maintenance. The house is constantly, during summer, dark and damage is being caused to house and road due to the fact little light passes through to dry out the property.

The sheer volume of falling leaves in autumn creates further issues with road and guttering needing increased regular maintenance.

We would appreciate a site visit where we would like to discuss, in person and more detail, the issues we have with these trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
