The proposed site is a semi-detached house set in a rural cluster of houses just outside of Watton at Stone. The existing house is a rendered semi-detached 2 storey house with an existing conservatory.

04. PROPOSAL

Description

This application seeks approval for the demolition of an existing conservatory and the introduction of a single-storey lean-to extension.

Scale

The proposed extension is designed to be subservient to the main house & respect the residential amenity of its neighbours.


The proposed extension will be 4m when measured from the existing back wall of the house. It is noted that this will mean the proposed extension sits approximately level with the existing neighbouring extension. Whilst the extension will be visible from the attached neighbour, it is noted that there are no windows in the side elevation and it is suggested that the increase in depth above and beyond that allowed by permitted developed will not cause adverse impact beyond that already permitted.

Design Considerations


The extension has been designed to maximise the usable floor area within the house.

The proposal is considered to use materials which tie in with the existing house and maintain the amenity of the conservation area.

The extension largely falls within permitted development but where it exceeds the permitted rules the impact is considered to be negligible.

Proposed Rear Elevation


