Reason: Possibly dangerous dead tree infested with ivy with overhanging branches on boundary with lane and public footpath

T2 (Holly): Fell tree

Reason: Possibly dangerous weak tree seriously infested with ivy overhanging boundary with lane and public footpath

T3 (Holly): Fell tree

Reason: Weak tree with sparse growth previously infested with ivy

T4 (Plum): Fell tree

Reason: Dying/dead tree previously severely pruned

T5 (Holly): Fell tree

Reason: Holly tree in inappropriate place (flower/shrub bed) now casting deep shadow on growing/living areas and encroaching on mature

## Additional Note:

Boundaries and flower beds at Church Villa have been variously neglected for a number of years by previous owners leaving them subject to overgrowth and infestation with ivy and holly. These works are intended to help bring these back to a state where they can be more easily managed and reduce any risks to users of the adjacent lane and public footpath. Works have been reviewed with a tree surgeon.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
