Identification of Tree(s) and Description of Works

There are 5 lime trees on our front boundary that borders the high street. They have become too large for the garden and are now growing too close to the house. The original house that was demolished in 2009 was replaced by 6 houses and was built further back from the trees so it was less of an issue.

We are also concerned that the branches overhanging are catching high sided vehicles and due to the size of the trees, the sheer number of leaves falling onto our property and the road are very dangerous when wet as they become very slippery. Additionally the size of the trees attracts a great many pigeons and the volume of pigeon excrement is a health hazard to us and passers by. We would like to apply to undertake a sensitive reduction of 3 to 4 metres.

When we moved to the property in 2015 we were granted permission to carry this out and again in 2019. It would appear that this work ideally does need to be carried out around every 4 years.
