Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1. There is a single large oak tree about 15 feet from the driveway entrance on Chatter Alley.
2. We would like to remove it completely.
3. It is leaning towards the roadway and we have been advised by Hampshire highways (in a circular) that any tree in private property that causes any form of obstruction to the highway is the responsibility of the landowner.
4. The tree has recently begun to drop branches of size up to 1.5m in length onto the shed and driveway below- these clearly represent a danger to the vehicles and family members in the drive and garden.
5. We have recently noticed that in moderate to strong wind the tree creaks and groans continuously.
6. Should the tree fall (due to it's lean, and high winds/weight of rainfall) it will crush either a part of the house, the shed and at least one car. It is also likely to fully or partially block Chatter Alley adjacent to a tight corner, in a 40mph zone.
7. The tree's branches are reaching across Chatter Alley and are rubbing on trees growing in Burnbake Copse, which we believe is not a good thing.
8. We had the tree crowned some years ago, but it has already grown back to larger than it's former size so now we believe it is more appropriate to remove it, especially since just crowning it will not remove the danger of the trunk coming down.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
