We would like to change the downstairs of our home, which is currently a fish and chip shop, into residential. So the chip shop area would become a lounge. This is all we want to do, this is only extending our existing living accomodation and not creating a new dwelling. No change to internal layout other than shop area will become a lounge. There will be no external physical alterations (other than the Bampton Fish Bar signage will be gone) - no change to windows. There is no increase in the number of dwellings. There will be no increase in the number of cars parked outside. There is no loss of employment as most of our young staff members have now gone on to work at Tesco. There is a sufficient range of suitable and available employment sites in the local area. There are existing takeaway businesses in Bampton, including a kebab place and a pizza van. There are several pubs (The Swan, Quarrymans Rest & Bridge House) and cafes that serve food. There is no commercial interest in the re-use of the site for employment, demonstrated by suitable marketing at an appropriate price for at least 18 months (proof in cover letter).
