Fell 16 diseased Ash trees and 1x poor quality Sycamore (T648) as detailed in arboricultural survey report. Several Ash trees are within falling distance of public highway. Trees are infected with Ash Dieback Disease and pose a health and safety risk to neighbouring highway and the residents using their garden. The diseased tree could also potentially damage existing healthy trees were they to fail

The replacement planting of at least 17x native species trees will be undertaken as part of a woodland management plan which is currently being compiled for the cover the whole site
