There are two large Ash trees remaining in group G2 on elevated bank at rear of property. Both have Dieback, but tree on left as seen from Medstead Road is in more advanced stage and has natural lean down the bank towards our property. We apply to fell this tree on the left, but will retain the more mature and larger tree on the right to see if it can survive Dieback for a longer period. We have consulted two tree surgeons on this, and both agreed with the decision to fell the left tree within this year to avoid it falling during bad weather.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
