Where timbers are rotten they will be replaced with oak and lath, with insulation and re rendering implemented in accordance with the details previously supplied. (e-mail of 15th March)

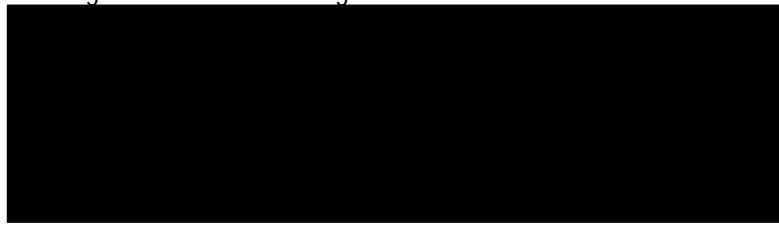
These works will be continuing on site until the 11th August 2023. Please can you confirm if the attached record is satisfactory. We will photograph the repairs before re-rendering.

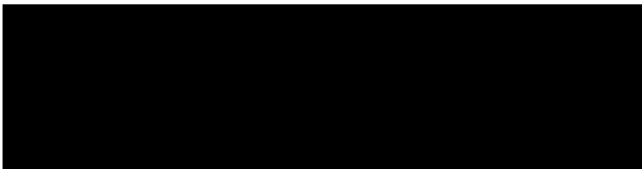


