# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Trim 1 tree only and as shown on the attached aerial photo.

We believe it is a beech.

Trim approximately 5m from the top and side branches out of contact of the BT cable.

Rationale:

. We intend to place PV panels on the stables roof (the cottage roof is not strong enough to support them). The current height of the tree shades the SW aspect which will reduce the efficiency of the panels. The intention of using PV panels is to remove the oil boiler.

2. The branches are heavily in contact with the BT line which may cause damage. They are also in contact with overhead electric cables in windy conditions. Further growth may cause damage.

3. The tree is affecting the tv signal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
