Good morning Judi

I've split the application for the above mentioned tree works application. The proposed works on the Cypresses need a little 'tidy up' and clarification: -  
**'reduce height of tallest section by 4-5m, trim on house side, trim on both ends and round corner as far as possible'**

It would be better to describe the finished height of the trees after the works has taken place much like when you reduce a hedge for example – so if you could redo this if appropriate and then referring to the description of 'trim', please state the amount of reduction required in cm/metres on house side, both ends and round the corner.

We await your response so that we can proceed with validating this application for you.
