Notification of an alleged breach of planning control had been received. Applicant was advised that the windows and doors that have been erected that create a balcony facing onto Carol House is in breach of condition 4 of application PL/2013/01625/FULL. The planning officer has advised that in order to rectify this, an option is to replace the set of patio doors with obscure glazed windows and fixed closed. They advised that we would need to submit a section 73 application to vary condition number 4 (along with condition 1) of application PL/2013/01625/FULL. This would allow the LPA to, if considered acceptable by the case officer, to vary the wording of the condition to incorporate obscure glazed and fixed closed windows. This would need to be accommodated by also varying condition 1 which covered the approved plans.
