Two conifers (one I think was an Ellwood's Pillar, the other I am not sure) planted around 20 years ago in our back garden approximately 8 feet from the rear of the property which were supposed to only grow to a maximum height of 6 feet have become overgrown and are presently at a height of 8-10 feet. This is cutting light from the dining room and the conifers have also grown into each other so that the inner sides of each have effectively died off and one of the conifers has also grown into an adjacent rose bush which is being damaged as a result. We wish to remove these two conifers as part of a project to replant the borders of the rear garden and have engaged a garden designer to assist in this process.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
