I consider that a Lawful Development Certificate should be granted for my proposal because all works we propose to carry out will be done to current regulations. We plan on building the extension in block using traditional building methods, the proposed extension would be 6 meters wide x 3 meters deep and roughly 4 meters in height. The extension would not include any verandas, balconies, or raised platforms. The extension will also not include any vents, soil pipes or chimneys. The extension will not exceed more than 50% of the total area of the curtilage.
