As approved, the garages between Plots 1 + 2 are semi-detached and share a party wall. This non-material amendment proposes that the garages are split. This will break up the form of the development when viewed from the road and will provide more desirable garages to the occupants of the houses which will not share a party wall which will simplify the maintenance of the garages and remove any likely disputes.
