I, LOUISE COVENTRY will say as follows:

- 1. I confirm that I live at 3, Buckleys Green, Alvechurch, Birmingham B48 7NG and was born in 1966. I work at the "garden nursery" at Goodway Farm.
- 2. I confirm that I first met Ron Haydon just over 21 years ago in 1999. I am living with his son Nick and that is how I met Ron. I can confirm that the Office part of the barn was already converted and in daily use to my knowledge when I first met Ron and I confirm it is my belief that it remains so. I firmly recollect that Ron started converting the rest of the building in 2002 when he was getting over cancer as he needed a project to occupy him. I know this because he used to ask my opinion and he built the archways because he knows I like them.
- 3. I have seen some photographs of the outside of the building taken in 2014 but as third party took them, I have not shown them as Exhibits. I have asked the acting agent to shown them for information purposes. I confirm that they demonstrate the outside of the building as I know it.
- 4. The building has had further modifications which I confirm were conducted by Ron from 2002 to 2009 though he employed an Electrician to do the fitting of the wiring etc.
- 5. I am shown a Survey Plan commissioned by Ron Haydon and marked Exhibit A and elevations at Exhibit B. I am also shown a Location and Block Plan and I confirm this is the location as edged in red. I confirm that the Office has been used as such continuously and without interruption from 2000 to the present day.
- 6. The building was converted as shown at Exhibits A and B from 2002 to 2009 [except the kennel and porch] and the remainder of it continued to be used commercially for the wholesale garden nursery.
- 7. All of the work done was open to all to see. Many people knew Ron was converting the building at the time as there are quite a number of visitors to the farm during each year who know Ron and that we have a "plant nursery" which delivers goods to shops.

I make this Witness Statement and Declaration under the provisions of the Statutory Declarations Act 1835 and I solemnly declare that I have made the above declarations conscientiously and solemnly believing them to be true.
