WE HAVE HAD ISSUES MAINTAINING THE EXISTING WOODEN WINDOWS WITH MODERN PAINTS AND ISSUES GETTING DECORATORS (THEY EITHER DON'T WANT OUTSIDE WORK, OR HAVE ISSUES WITH WEATHER AND TIMINGS). I HAVE HAD TO STRUGGLE TO PATCH THEM UP MYSELF AND DON'T BELIEVE REPLACING THEM WITH WOODEN WINDOWS AGAIN IS A GOOD SOLUTION.

THE PROPOSED REPLACEMENT WINDOWS AND DOOR WILL LOOK VERY SIMILAR TO THE EXISTING ONES (FLUSH CASEMENT, TIMBER LOOK JOINTS AND ONE HORIZONTAL BAR) AND ALTHOUGH THE MATERIAL IS DIFFERENT, IT IS DESIGNED AS A TIMBER ALTERNATIVE WITH TIMBER LOOKING JOINTS.

I BELIEVE THAT THIS SOLUTION WILL BE VERY SIMILAR IN LOOK TO THE ORIGINAL AND WILL BE VERY MUCH IN KEEPING WITH THE AREA.
