Thereby reducing the reliance on fossil fuels whilst also lowering carbon emissions. The estimated annual electricity generation from the ground mounted solar PV system is approximately 47,000kWh which equates to a carbon savings of up to 16.5tCO2e/year based on the reduction on reliance on the grid which is the equivalent
