Standard holly tree to the side of the house, we have plans to tidy up this area so it is better utilised but the tree is in the way. We want to remove the holly tree and in it's place install a pond and a seating area, we will plant a replacement tree in the rear garden. There is only a single tree affected

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
