There are three heavily leaning pines to be removed in a small wooded plantation to the rear of the property, which have been identified to come down, i am lead to believe Clive Dawson has been to site to see these pines with the owner David Gowans. Although the pine trees are mature, there are other trees in the area which still give a good tree line. There is also a sycamore adjacent to the corner of the property, its thought to not have a TPO but i am wondering if thats true, and or if its in conservation? if so i am looking for permission to also remove this tree.

## Identification of Tree(s) and Description of Works

- Pine 1 Heavily leaning tree
- Pine 2 Heavily leaning Pine
- Pine 3 Heavily Leaning pine

All three of these Pines, are mature trees and all have severe leans, it is of concern that it is only a matter of time before one or more of them might fall especially in windy conditions.

Sycamore - im lead to believe this tree is out of conservation and doesnt have a TPO, but im asking that this is checked and then if it is within either catergory you will take this as my application or notification that we plan to remove this tree as it is causing problems with the drainage pipes from the house.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
