For a number of unforeseen circumstances, the build has progressed much slower than anticipated and as our children have now left home, we are selling and downsizing. During the lull in building I inadvertently missed the landscape paperwork deadline, which I am now seeking to normalise through submission of the revised tree and landscape schedule. I attach the original tree schedule drawing downloaded from your portal, from which I have extracted the tree location detail. I have then show the original tree planting and also the revised planting showing new trees, their size and location. I am pleased to confirm that all are in good condition and thriving. Condition 4. During the planning stages I was guided by one of your planners, Patrick Gear, who was exceptionally helpful. The planning application was granted with the inclusion of Condition 4. At the time Patrick explained informally that this condition had been removed in many cases following appeal and that on this basis if I were to write to the Council asking for it to be removed, I might expect a successful outcome.
