Oak tree in middle of rear garden is on a significant lean and it overhanging significantly over conservatory roof. We would like the full removal of the tree as if it falls and someone is under the conservatory roof it could kill them.

We contacted local tree surgeon Ben Chambers to evaluate the above situation.
