History

Part Q applications on this building has been submitted and approved twice in the Last 3 years.

The building alteration work has commenced, and due to site conditions, building regulation requirements,, which have dictated change to working practice for the project.

The front facing the road is unaltered from the last approval, this also applies to the end elevations, however the rear has changed, driven by the building regulations for escape windows to the two of the three rear bedrooms, and the retention of the existing king post trusses, these are centred on the main body of the home., and the increased rafters for insulation has increased the roof. This has dictated the height to the rear elevation and has increased the height of the rear wall by .500mm, we ask you to note the ridge height has moved central to the main body with the ridge being .500mm higher.

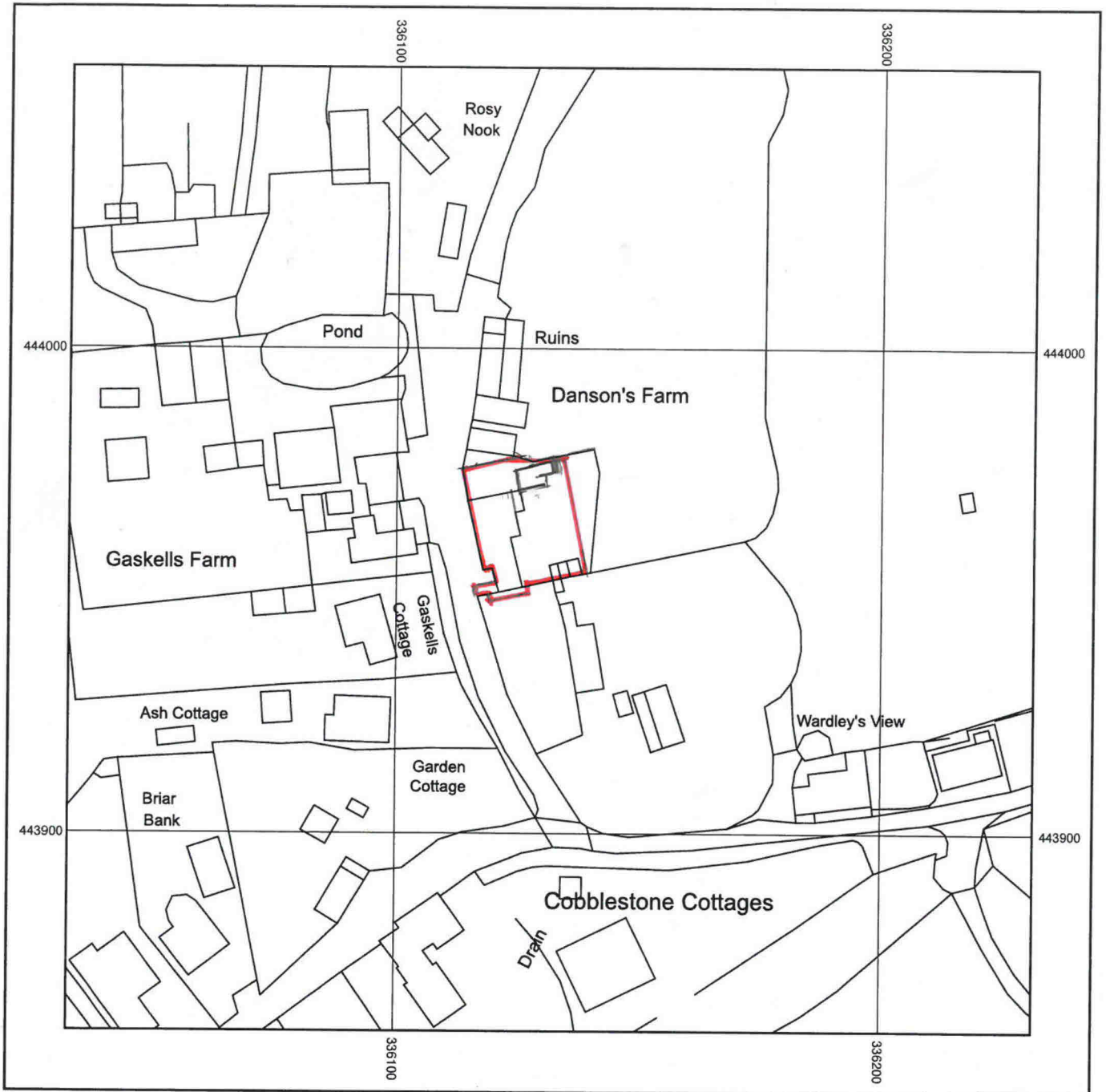
Building regs has had a significant affect on the project with the gas membrane the tanking and the internal structure to create a solid and insulated building, The retention of the trusses now braced and solid the exposed interior and the need for insulation to the roof space has also contributed to the rise of the ridge. Structural stability insulation and site conditions has enhanced the need for this re submission.

This submission also asks for permission for a detached garage to the rear, this forms part of the submission, basically its a double garage with an office over accessed by a rear stair the construction is as shown using traditional materials and the form of an old timber structure.

The project is on site and we respectfully ask for your permission.
