Identification of Tree(s) and Description of Works

One Conifer to be shaped as overgrowing neighbour's property with potential damage to property. The tree is not subject to TPO. It was reduced in height several years ago and has no amenity value. We are told by former owner this is a sucker tree allowed to grow with the mother tree removed before we moved in.

Shaping includes reducing the east facing by c 3 metres and south, west & north c 2metres

Whilst we seek approval to shape the tree we also ask for ratification that we may also fell the tree in event the work costings and alternative tree planting are considered. No one will quote without this council approval first.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
