then you may appeal to the National Assembly for Wales in accordance with Section 78 or 195, whichever is applicable, of the Town and Country Planning Act 1990.

To appeal you must use a form which can be obtained online at <https://www.gov.uk/appeal-planning-inspectorate> or from the Planning inspectorate at Crown Buildings, Cathays Park, Cardiff, CF10 3NQ. You must appeal within 6 months from the 16 October 2023.

Please note that post submission amendments to an application will extend the statutory time period for determination of the application by 4 weeks from the date the amendment was received or 12 weeks from the 21 August 2023, whichever is the later (target date for this application has been calculated as 16 October 2023).

Please note that significant change to drainage requirements will impact new developments from January 2019. From 7 January 2019, all new developments of more than 1 house or where the construction area is of 100m² or more will require sustainable drainage to manage on-site surface water. Surface water drainage systems must be designed and built in accordance with mandatory standards for sustainable drainage published by Welsh ministers.
