- T2 Willow. Pollard at a height of between 7 and 9 metres. Bridge to property threatened and tree leaning towards annexe.
- T3 Cherry. Remove. Severe lean threatening parked cars.
- T4 Cherry. Remove. Severe lean threatening parked cars.
- T5 Oak. Reduce crown by 20%. To let light into garden and lessen threat to garden shed.
