T1 - Oak - Remove epicormic growth from the trunk up to the crown break.

Thin the canopy by 15%

Cut back canopy to ensure a 3m clearance from the fabric of the house.

The canopy is very dense with quality foliage that can easily except a crown thin to allow light into the garden area, We need to ensure clearance from the building to minimise abatement

T2 - Birch - Fell to ground level - Tree is in poor condition, showing dieback in the crown. Its surrounded by concrete and has limited life expectancy

T3 - Copper Beech - Crown raise lower canopy to 3m

Thin the inner canopy out by 20% to allow light penetration.

Reduce by up to 50cm the very lateral tips of the upper canopy to reshape.

General tree maintenance. This has been done before and is needed to allow light to the garden without damaging the form of the tree. I appreciate a reduction would be the last solution but all I am proposing is a very slight tip reduction to selective limbs outside of the canopy shape

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
