T1 1x Oak reduce entire crown by approx. 2-2.5m, remove deadwood over 20mm in diameter and reduce lateral branches by approx. 1.5m - 2m to give up to 2.5m clearance to the house.

The works are requested to help maintain the tree's current size by not allowing it to get bigger and to give clearance to the house.

Crown height is approx. 13-14m and crown spread is approx. 14-15m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
