Elm (T3,T4) -Fell as low to ground level as practicably possible, left side of exit road at the top of park. 3a Woodlands Way: Oak (T5) -Remove epicormic growth up to first true branch. 4 Woodlands Way: Hawthorn (T6) -Fell as low to ground level as practicably possible. 13 Woodlands Way Oak (T8) -Crown lift over roof of home to give up to a 2m clearance. 2a Shepherds Grove (Rear of 8 Shepherds Grove) Silver Birch (T9) -Crown lift to 3.5-4m above ground level. 35 Shepherds Grove Larch (T10) -Crown lift to 3.5-4m above ground level. 124 Shepherds Grove Oak (T11) - Crown lift to 4m above ground level over road side only. 105a Shepherds Grove Conifer (12) -Trim back/remove stems to give approx. 0.5-0.75m clearance to home.
