- 1. Ash tree by house re reduce to near or previous points, cuts no more than 40mm across, branch length no more than 1.5 to 2m depending on suitable pruning points.
- 2. Horse Chestnut, rear garden, re reduce to previous or near suitable pruning points, cuts no more than 35mm, branch length up to 1.5m
