T1 Oak (Located by pin on what3words)

A group of edge row trees along the rear garden of the properties. Remove the lowest overextended limb back to stem and reduce lower canopy away from the property by 2m

Reduce the weight out of the canopy and to reduce the amount the canopy has grown into the rear garden searching for light. The work wouldn't be seen from the street and wouldn't unbalance the canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
