T1 Cedar - recent failure in he upper southerm (roadside) canopy at 10m in height, which struck BT and failed over the road. Multiple hung up branches in the canopy. Over extending canopy specifically to the South East.	

Spec:

Inspect failure point at 10m in height, removal of remaining limb may be required depending on the severity of the failure site. Selectively Reduce the south eastern aspect of the canopy by 4-5m to bring within the natural canopy line. All remaining aspects to be selectively reduced by a maximum of 3m. (see annotated photos), remove all the hung up branches and any deadwood over 30mm diameter throughout the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
