Presently there are no front entrance gates across the tarmac finished front access drive.

Proposed materials and finishes:

Preservative treated softwood timber for the two new entrance gates and posts. (The posts may need to be hardwood as they will be set into concrete in holes excavated through the existing tarmac drive). Gate fittings (hinge/hooks and catches etc) will be galvanised metal or black finished metal.

Type:

Vehicle access and hard standing

Existing materials and finishes:

Existing flower border along the south edge of the tarmac drive will need to be removed to provide access to pave for the south centre hand gate.

Proposed materials and finishes:

A new area of path will need to be made on both sides of the new pedestrian hand gate. This will be made of rolled stone hardcore base with a topping of gravel, stone slabs or tarmac to match the existing drive surface.
