T1 Mature Apple tree in rear garden, The tree height is 4m and crown spread is: 4m. Stem dia: 300mm. The tree has loose bark from ground level which leads up the stem to approx 1m. the bark has white mycelial sheet present on the underside of the bark. This has been identified as Honey fungus likely considered in the early stages of decline. Recommendations: given the identification of the fungus and the infection to the tree, it is advised for removal to ground level.

T2 Mature Golden Rain Tree. Height: 7m Crown spread: 6m The tree has shown over extended lateral growth to the East and West sides of

Recommendations: Crown reduction of 2m. Height to be reduced from 7m to 5m. and Crown spread reduced from 5m to 3m.

canopy, due to tree group pressure from North and South sides. Unbalanced crown.

All tree works to BS3998 (2010) No pruning wounds to exceed 50mm in dia.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
