T1 Acer pseudoplatanus, Age mature, DBH 900, Height 11.5m, Crown Spread 8.2m Works proposed: A crown reduction of secondary and tertiary branches of a maximum of 1.5m in order to reduce overall crown volume and improve visual amenity value.
