Please give a brief description of the current state of the site and a description of any existing buildings and their current and former uses.	The site is part of the overall plot of The Old Apple Farm. The existing barn forms a natural boundary and creates a separate site for the proposed dwelling to the south. The existing barn on-site and adjacent site forming the proposed plot are presently vacant and unused by the owners. The barn is in a poor state and is considered to be of no architectural or historical importance. It has a metal corrugated sheet roof and poorly maintained feather-edge weatherboarded walls. The timber frame combines original oak work and more modern softwood.

Please give a brief description of the proposed layout of the site, including any hard landscaping and garden areas planned for the development (please provide a plan of the location of these areas).	The proposal is for a three-bedroom dwelling with generous living, and kitchen accommodations and a single garage is proposed. The site is sufficient to provide parking, vehicle turning and amenity space. A driveway will have a gravel finish whilst the remainder of the site will be laid to lawn. There will be a patio area to the southwest of the dwelling.
