- T2: Fell previously pollarded Oak trunk with poor re-growth.
- T3 & 4: Fell 2 weak Oaks to thin Oak grove a little leaving 16 Oaks.
- T5: Remove lowest branch of Sweet Chestnut to allow more light into the understorey.
- T6: Reduce side branch of previously pollarded Oak overhanging the drive.
- T7 & 8: Continue re-shaping Hornbeams to make them a more 2D linear form.
