## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1) Fell to ground 1 x Quercus (Oak) – Tree of poor quality, leaning over at approx. 30-40 degree angle, risk of damage to other trees/fence/property, and growing immediately adjacent to a better quality Larch Tree, which should be retained – see photos

T2) Fell to ground 1 x Cupressus – Dead tree – appreciate this isn't notifiable, but for clarity wanted to include this in the application – see photos

T3) Fell to ground 1 x Elm - Tree of poor landscape value, growing into the canopy of adjacent Holly Tree, remove to provide sufficient clearance to other trees - see photos

T4) Structural pruning/Crown reduction 1 x Acer Sycamore – Maximum 3M all around – Tree Surgeons noted active rot at base of tree, which has caused a hollowing out of main core. Plan to decrease some of the canopy 'weight/load' to reduce strain on tree base, with sympathetic structural pruning/reduction to maintain the attractive shape of the tree – hopefully alleviate the need for premature removal of the tree - see photos

G5) Fell/Remove Sycamore saplings under 50mm in diameter towards back of woodland area & small 're-shoots' of Holly Bush - Previously cut down, and not properly removed - in the interest of thinning woodland to preserve space for better/bigger trees - see photos

G6) Group of Laurels on eastern boundary of woodland – Reduce to 1.5M-2M and reshape Hedgerow/understory - encroaching on other areas of woodland - Not part of the original 'native woodland'

### NON NOTIFIABLE TPO WORK TO INCLUDE

Felling of 4 small Elm trees, outside of TPO, closer to back of property, all of poor landscape value and early indications of the presence of Dutch Elm disease

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
