1. INTRODUCTION

This Planning Conditions Statement has been prepared by MAT Design Limited on behalf of Mr D McDonagh and forms part of the conditions discharge application submission to Cheshire West & Chester Council that proposes to agree and seek to discharge planning conditions 3, 4, 5, 6, 7, 8, 10, 11, 12 & 13 that were attached by the planning application decision 22/02273/FUL made on 22nd May 2023.

3. CONDITIONS TO BE DISCHARGED

The conditions that we propose to discharge are 3, 4, 5, 6, 7, 8, 10, 11, 12 & 13 that were attached by the planning application decision 22/02273/FUL made on 22nd May 2023.

4. CONDITON 3

Please see the revised site plan showing the highway access work specifications.

5. CONDITION 4

Sewage – Given that there are no stable connection points available, and that the site is currently served by septic tank arrangements, a sealed 3800 ltr Kalrgester Septic Tank provides the site sewage arrangements. We consider that this is the most sustainable and most suitable option for this site and the site pitches, as there is no suitable discharge point for a package sewage treatment plant onto a suitable discharge bed.

The details of the tank are attached to the application.

6. CONDITION 5

Small 10 watt battery operated lights are to be attached to each of the static homes. There is no other external lighting proposed as part of this application.

The details of the lights are attached to the application.

7. CONDITION 6

Sustainable surface water drainage – An engineers report has been prepared that assesses the surface water drainage within the site.

The report is attached to the application.

8. CONDITION 7

Soft landscaping and tree planting – Please see the revised site plan and the recommendations in the Preliminary Ecological Appraisal.

In terms of the site planting programme, and taking into account the site layout, ground conditions an topography, we intend to utilise a combination of Honeysuckle & Ivy Climbers, along with a mix of ferns that will be planted inside the site fence that has been approved.

In terms of the site planting programme, and taking into account the site layout, ground conditions an topography, we intend to utilise a combination of Honeysuckle & Ivy Climbers, along with a mix of ferns that will be planted inside the site fence that has been approved.

On the opposite (outer side of the fence), we intend to form a hedgerow boundary to the outer side of the fence. This will consist of Hawthorn, Blackthorn, Holly & Hazel.

In terms of additional biodiversity enhancement measures, when one considers the development as a whole, there are no opportunities to introduce Bat, Breeding Bird Boxes or Bee Bricks.

However, we consider that there may be enhancement opportunities to include enhancing the site for Hedgehogs and/or providing deadwood and other semi-natural provisions.

We have not identified these elements on the revised site plan and we are happy to accept any positive advice from the LPA Ecologist with regarding to the above, and to the advice in the Preliminary Ecological Appraisal.
