Reduce lower southern and south western area of crown by up to 1.5 metres to 2 metres back from neighbouring property, crown lift lower branches on south western aspect of tree back from neighbouring garden to allow up to 3 metres clearance. T2 Mature Lime. Remove large suckering stems developing from basal area. Crown lift northern aspect of lower crown area away from neighbouring property.

T3 Mature Laylandii. Remove to ground level.
