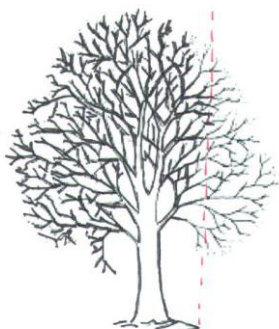
Arboricultural statement

The following arboricultural statement makes management recommendation for trees at the above property.

T1. Sycamore (located in the adjacent property) – prune back all overhanging growth back to the boundary line using industry best practice (this could mean that the final pruning cut is located either side of the boundary fence depending on the form of the branch

This work is requested to remove problematic branches overhanging the garden and dropping debris onto the patio area.

Crown clearance



Crown clearance is the pruning back or the removal of branches that are encroaching towards an object such as a building/structure/lawn by a given amount. Good practice dictates crown lifting should not normally include the removal of large branches growing directly from the trunk as this can cause large wounds which can become extensively decayed leading to further long term problems or more short term instability. Crown clearance should be specified with reference to a fixed point, e.g. 'crown clear or prune back by 4m'.
