Following an incident where a 7-8 meter 9-10" diameter branch broke off and as a result landed on top of a child's trampoline and completely demolishing it. Thankfully my children were not playing on the trampoline at the time but could quite easily have do. Incidentally the trampoline was "not" positioned under the tree in question. (See pics)

Due to the severity of this incident, I contacted my Tree Surgen, where he offered advice and detailed a plan of action with regards to reducing the chances of this happening again, thus carrying out work on the affected tree, on close inspection, a further two additional trees were highlighted requiring work for safety reasons.

## Identification of Tree(s) and Description of Works

The following details have been advised by my Tree Surgeon, the ID Tag numbers relate to a previous Tree Report carried out by David Gillett Tree Services. (Report will be attached)

### Tree Tag857 (beech tree)

In order to reduce the weight of branches, I propose to reduce the outer limb by 2 metres from this tree and thin out internal branches.

The tree is located at the back of the property and is the main area for children to play and by carrying out the above work would reduce the risks of unexpected breakage of large branches.

Tree Tag862 (beech tree)

This is the tree where a 7m 9-10" diameter branch broke in non-forceful weather i.e. storms or high winds. The branch demolished the trampoline where the children play.

NNDC have approved to reduce the crown by 1-2 metres; to prevent further damage to property and to reduce the risk to injury to anyone on the property, I would recommend a reduction of between 3-4 metres to allow for regrowth and to prevent further incidents.

Tree Tag 869 (beech tree)

Location at the back of the property near the caravan.

This beech tree has had many limbs come down over time.

It has a few large rot holes from previous limb removals and has a large lower limb that has signs of cracking. This is so heavy the limb is bending down.

I would like to remove the lower branch, incase it was to snap unexpectedly causing damage to property or injury to someone.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
