The property has sat empty for several years since the previous owner past away and the house and garden has fallen in disrepair and extremely overgrown, the new owner would like to re landscape the rear garden with new planting, there are two self seeded ash trees at the rear of the garden which cause excessive shading to the neighbours properties as well as number 85, the owner would like these cut to ground level, at the front of the house is a conifer hedge, the owner would like to remove this hedge and repair or replace the existing wall and then replant a similar hedge.
