- 1.Reduce apple tree to previous reduction points (approx finished dimension 3m)
- 2. Crown and thin large box to expose the trunk and main branch structure
- 3.Rediuce crown of portugese laurel by approx 50% (approx finished dimension 3m)
- 4. Trim top and both sides of lonicera hedge to formalize
- 5.Reduce crown of magnolia by approx 50% (approx finished dimension 2m)
- 6. Tidy up and shape 2 hawthorne trees into ball shapes as they were when we moved in

We're doing these works to tidy the trees up as they are becoming over grown. The laural will start to overhang the pavement and the magnolia is blocking all light from the windows.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
