T1 . Ash . Reduce lateral growth of R/H of crown by approx 3-4m to minimise limb failure while retaining a natural profile. Tree has very early signs of Ash Dieback.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
