Thank you for consulting the Forestry Group on application No: 23/0677/TC - Cutting back of 1 cherry tree to side of property and cutting back of 1 oak tree to rear of property.

The cherry to the front of the property is visible from the main road and contribute towards the general character of the road. The oak is located to the rear of property and not obviously visible. The proposed works within the application are to cut back from the property are minor in nature and would be considered routine tree maintenance. For the benefit of doubt it would be useful to have within the works description an estimation of length/measurement for the proposed pruning works e.g. cut back to ensure 1m clearance from property.
