A large mature holly tree is leaning to one side and has a large branch over a gateway which I consider to be dangerous.

I would like to have the horizontal branch trimmed off to give the tree a more upright appearance and to distribute the weight more evenly.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
