There are 9 Trees which have overgrown the area they they are located and we would like to have them removed to ground level. There are 3 growing through the boundaries of the neighbouring properties and 2 are dead due to being infested with vines. Due to their locations surrounded by properties and their size, if any were to be blown down or branches fall they would cause a great deal of damage to the surrounding properties. The other trees are smaller, but I wanted to include them just to be sure that they would be able to be removed. I have included the site survey with the location of the trees along with numbered picures which shows each individual tree. I have also included site location map.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
