T1:- Sycamore- Remove X2 branches back to trunk. These branches are overhanging a Biomass container and due to the weight of the branches they are starting to pull towards the Biomass container. Due to this there are concerns that with the weight in the branches they could fail and then fall onto the Biomass container and cause damage to it. By removing the X2 branches this would make it completely safe from any damage. The length of the reduction of the X2 branches are approx 4-5 metres back to trunk.

There are a selection of other trees within the property where work is going to be commenced on them. The only work that is being done to these trees is to remove the dead wood within the canopies; no live wood will be removed but as part of transpancity it will be attached to this application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
